Abstract Submission GUIDELINES

The paper should begin with title, followed by author names and affiliation, short abstract and a list of keywords. Simultaneous submissions (papers already submitted to other conferences/journals) are not allowed. All papers must be submitted in pdf or docx form following the instructions mentioned below.

Abstract Title:

- ☐ 14 pt. Times New Roman, centre aligned
- ☐ Title should be given in sentence case
- ☐ Abbreviations should be avoided except for the common well-known terms
- ☐ Keywords Minimum 3-7

Authors' Name & Affiliation:

- ☐ 12 pt. Times New Roman, Centre aligned
- ☐ Present the authors' affiliation addresses below the names (designation not to be included). Indicate all affiliations with a lower-case superscript letter immediately after the author's name and in front of the appropriate address. Provide the full postal address of each affiliation, including the country name (Pin code not to be included).
- ☐ E-mail address and mobile number of the presenting author to be included
- ☐ Presenting author needs to be indicated by an Asterisk
- ☐ Multiple departments and Institutes should be numbered (superscript) before the department

Upon Acceptance

The acceptance of the abstract along with the oral presentation guidelines and template shall be intimated via mail to the presenting /corresponding author as mentioned.

Note:

The presenting author has to mandatorily register for the conference. Only offline oral presentations via E-poster is allowed. Certificates will be provided only to the authors who have registered.

Abstract:

- ☐ Abstract heading to be written in all caps, 14 pt. Times New Roman
- ☐ Word limit not more than 250 words.
- ☐ Structured abstract with the following subheadings in bold:
 - (a) Background and Objective
 - (b) Materials and methods
 - (c) Results/Discussion
 - (d) Conclusion
- ☐ Abstract body: 12 pt. Times New Roman Justified
- ☐ Line spacing to be 1.5
- ☐ Standard Scientific Nomenclature to be followed for Genus and species

Keywords

- ☐ Minimum 5 to 7 keywords to be provided.

Page Setup:

- ☐ Set the top, bottom, and side margins of your paper at 2.5 cm.

PUBLICATIONS:

- ☐ **CONFERENCE PROCEEDINGS:** All accepted abstracts will be published in the conference proceedings with ISBN (Soft copy will be issued).
- ☐ **JOURNAL PUBLICATION:** The abstracts with novelty will be shortlisted for full-length manuscript submission to Scopus/ Web of Science indexed journals.
